

PREPARATION FOR A PROPERTY ENGINEERING VISIT

Property insurance coverage has never been an exciting topic for an article, but in the past few years it has now pushed its way into prominence. Over the past decade or so, the insurance companies have lost a lot of money due to large disasters such as hurricanes and wildfires. They have become increasingly careful about the risk they take on. This means their engineers are looking harder at their insureds. Issues which have been passed by for a decade are suddenly being written up, spotlighting major issues which were there all along.

In a typical case I've been seeing more of lately, a decade of growth has led to a client's property protection problems also expanding. It would have been easier to fix them as the company grew simply by making sure the new structure met the applicable NFPA codes. Instead, fire codes were neglected, the corrections are projected to cost well into the seven figures, and the insurance company doesn't intend to cover the full value of of the property unless critical improvements are made.

The plant management felt clotheslined by the engineer's findings. Now, the management is struggling to understand not only how to pay for everything they need but also why they have been put into this predicament. This week alone, I've worked with three companies who just found themselves all in the same boat.

As we know, good management includes planning and budgeting for significant expenses. Bringing a new, unexpected multi-million dollar project to the board or the ownership is going to be unpleasant. That's doubly true when the reason for the surprise is a failure to consider property protection measures in the expansion plans. Sure, our builder might have installed a garden-variety sprinkler system, but it's not enough for what it's supposed to protect.

Since there are plenty of companies out there which haven't yet been given this wakeup call, this month's column is about facilitating a visit from an insurance property engineer to at least make it easier and more efficient when a property engineer visits.

The engineer is the eyes and ears of the insurance company. Each visit will result in a report with whatever recommendations the engineer decided made sense. In most cases they are looking for anything which doesn't meet a code or standard, but they also have their own best practices which they want their insureds to follow. Engineering surveys can be as often as yearly, and the engineer may want to visit again sooner if there is something which needs to be followed up on.

Although this can seem like an intrusion, keep in mind an important part of any business is keeping that business in operation. The carrier engineers are there to point out issues which could cause future problems. It's a valuable free service which would cost thousands if you hired an outside expert for that purpose. It's also better when your insurance company sees you as a cooperative partner. If there is something in the recommendations you can reasonably do, then you should think seriously about it.

3) Review of any outstanding recommendations if there are any and review human element procedures,

For most visits, the survey will follow the following format:

¹⁾ Opening meeting, introducing scope and schedule of the visit

²⁾ Discussion of the site layout, construction/age of the building and the roof, as well as occupancies and processes in the building. Any site changes (construction, remolding, upgrades etc.) since the last site visit if there was one, as well as any planned changes. Engineers are also interested in the neighboring businesses and any unusual hazards to your building from the neighbors.

smoking controls, hot work, impairment handling, emergency preparedness, fire prevention inspections, contractor controls, security arrangements and utilities. This process is more efficient if you can have documents printed out and waiting.

4) Tour of the site. The tour can include general building areas, utility rooms, the roof, fire protection equipment/room, electrical rooms, boiler room, and data center. Sprinkler risers are of high interest. Some engineers will want to see sprinkler control valves exercised and witness other hands-on tests. It's always a good idea to prepare for property walkthroughs by sending someone out to look for and fix the little housekeeping issues which will inevitably need to be corrected anyway after the inspection. It's not possible to list everything, but here are some of the top "hot button" issues:

- Idle wood pallets stacked more than six feet high indoors, pallets outdoors up against the building, or pallets stored in storage racks (note plastic pallets must be in shorter stacks with less in any given space)
- Fire doors propped open or items left underneath overhead fire doors so they can't close completely
- Any stray containers of flammable/combustible liquids which are stored in racks outside the designated flammable storage areas.
- Cardboard, wood etc. stored in utility rooms such as electrical rooms or telephone system rooms
- · Storage piled within 36" of warehouse sprinkler heads, within 18" of plant sprinkler heads
- Flammable containers not bonded and grounded for transferring into other containers, more than a day's use on the plant floor.
- Combustibles such as plastics or corrugated cardboard accumulated under stair landings and mezzanines where there are no sprinkler heads
- Closed sprinkler control valves (this is very important since it wipes out the fire protection)
- Hydraulic machines and HVLS fans without interlocks to shut them down in case of a fire
- Any defect in automatic extinguishing systems in spray booths, paint rooms and flammable storage (for example, in a spray booth, sprinkler heads with paint on them)

5) Final conference with senior management to present findings and recommendations.

If your property carrier hasn't seen your facility for a very long time and you feel like there's going to be a reckoning, why not have an engineer from your insurance broker do a pre-visit walkthrough? We want our insurance partners to leave your facilities with a smile, not a long list of problems. It's good to be prepared and cooperative.

Additionally, Courtney Hobbie, Director of Safety Kozeny Wagner, knowing about the challenges getting supplies while in the field, has added period supplies to first aid kits and worked to ensure all employees that may need them know about their availability. She has also added these supplies to the list of what must be inspected in the first aid kits.

Kathi Dobson, Safety Director, Alberici, has also been working to improve hygiene at job sites. She has made period packs for Alberici employees and some have been distributed to MOWIT members.



She is also paying attention to general sanitation practices in the field to include providing access to sanitary products, disposal methods for these products, exploring "accessible" porta-potties for women as doffing work clothes in the tight quarters can be challenging.

All of these to make the job sites more inclusive, safe and inviting for tradeswomen.
