

Update On Second Injury Fund

Liability Geeky Attorneys like myself practicing in the area of Missouri workers' compensation are awaiting the opinion from the Eastern District Court of Appeals in a case called **Jerry Thomas** and an opinion from the Missouri Supreme Court by the name of **James Eckardt**. Jerry Thomas deals with a critical issue as to whether an Employer will be held responsible for permanent total disability if the Second Injury Fund is found not be liable under the new statutory restrictions on their liability in place since 2014.

To quote from a 1964 court opinion:

"What liability is not the responsibility of the Second Injury Fund, might be retained by the Employer."

Under the facts in this case, all the vocational experts agreed that the Claimant was totally disabled. One of the pre-existing disabilities stemmed from an Iowa workers' compensation case and the other prior knee injury stemmed from a prior Missouri accident. The prior Missouri case was resolved for 40 weeks of compensation which is below the 50 week minimum allowed for consideration. It could be that the court will allow both prior knees to be considered in light of the medical testimony to a greater percentage of PPD in each knee immediately prior to the primary accident. We shall see.

James Eckardt deals with an award provided for permanent total disability that included consideration of many qualifying pre-existing disabilities but also consideration of a 48 week prior shoulder injury. *Will the Missouri Supreme Court disallow the total benefits being payable?*

Another issue was the consideration of a prior disability that qualified for being greater than 50 weeks but it was related to an occupational disease and not an accident. Under section 287.220, the statute provides that the prior disability combine be:

"ii. A direct result of a compensable injury as defined in section 287.020"

Section 287.020 defines "accident." "Occupational diseases" are defined under 287.067. Likely an oversight by the drafters of the section, but under strict construction...?

Both cases are in the process of appeals and briefs will be filed and oral argument scheduled early Spring, with decisions likely in May or so I would guess.

Understanding how the law and statute is being interpreted and where the case law is headed is an important part of the experience and knowledge we hope is acknowledged and appreciated by our clients. It is like a game of chess, which is a game I enjoy playing; whoever can think farther ahead usually wins.


Key Life Lessons




